"My favourite development is The Knightsbridge where the penthouses sold for £17 million each in 2007; it provides five-star hotel style services for apartment owners. I believe one penthouse recently sold for £90 million – if only! Many of the developments I worked on were sold off-plan to foreign buyers and I was lucky to attend exhibitions in Singapore and Hong Kong; it certainly made life interesting."

## Seeking a kiwi lifestyle for family

The lure, however, of a Kiwi upbringing and more space for their family (a lifestyle block vs a terraced house) saw Stephanie and her husband, Dwayne, move to Whanganui 16 years ago. Stephanie recalls it being a bit fraught packing up a house and flying half-way around the world with a small daughter, four-week-old twins – and recovering from a caesarean section. "Well, you just get on with it!" life in New Zealand and I could build up my work hours as my children grew up. Horsley Christie was, and continues to be, a very family-friendly firm."
